Ini untuk memaklumkan bahawa Unit Pengurusan Ladang di bawah Syarikat Induk IOI Corporation Berhad dengan nombor keahlian RSPO 2-0002-04-000-00 telah melantik Intertek Certification International Sdn Bhd untuk menjalankan ~~Audit Pengesahan / Pengesahan Semula (RA-02) /~~ Audit Pengawasan Tahunan/**Extension of Scope Audit** ke atas Kilang Sawit Leepang dan pangkalan bekalan /estet yang terletak di Lahad Datu, Sabah. Pengauditan akan dilakukan pada **24 October 2026** dengan syarat:

- Malaysia National Interpretation (MY-NI 2025)
- RSPO Principles & Criteria (P&C 2024)

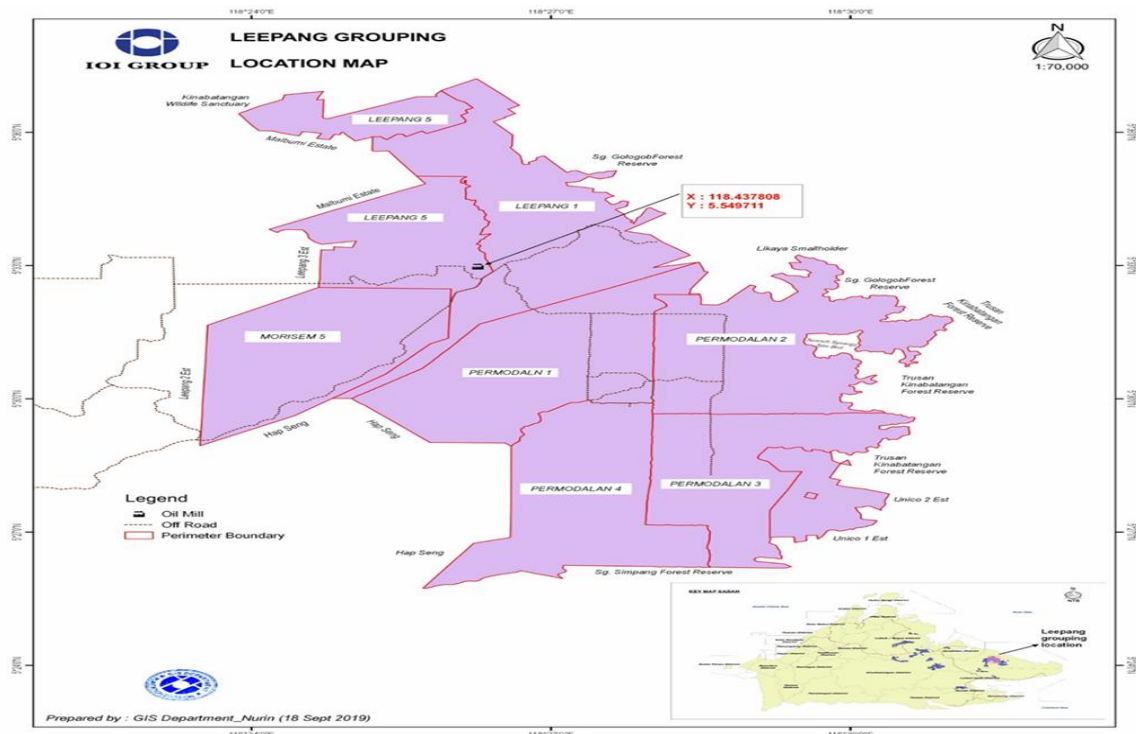
